Refer a Friend Terms and Conditions

These terms and conditions may be reviewed and amended from time to time and does not form part of a client's Home Care Agreement.

HenderCare reserves the right to change the program rules or suspend or terminate the Referral a Friend Program at any time. The Refer a Friend Program opens 1 August 2025 and closes 31 October 2025, unless otherwise terminated.

Eligibility Rules

- Existing HenderCare Support at Home clients may refer a Home Care Package client to HenderCare Support at Home in any State or Territory in Australia (excluding the Northern Territory).
- Commonwealth Home Support Programme clients are not included in this incentive program.
- The referee (new client) must have an existing and current allocated Home Care Package (HCP). People who are still in the process of applying, or waiting for the allocation of an HCP, will not be eligible.
- Referees (new clients) can be new clients to HenderCare or returning clients that have previously been HenderCare clients and decide to return as a result of the referral.
